

**CrossCountry Mortgage Dedicated Dawgs Sweepstakes
Official Rules**

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED OR WHERE SWEEPSTAKES BONDING IS REQUIRED BY LAW. 1. Eligibility: The CrossCountry Mortgage Dedicated Dawgs Sweepstakes (the "Sweepstakes") is open to all legal residents of the United States who are eighteen (18) years of age or older as of the date of entry and who reside in states in which sweepstakes bonding is not required by law. Cleveland Browns Football Company LLC ("Sponsor") is located at 76 Lou Groza Blvd., Berea, OH 44017.
