Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. BY PARTICIPATING IN THE SWEEPSTAKES, PARTICIPANT AGREES TO BE BOUND BY THESE OFFICIAL RULES, THE DECISIONS OF SPONSOR (WHICH SHALL BE FINAL IN ALL RESPECTS), AND THE CLEVELAND BROWNS PRIVACY POLICY FOUND [HERE](#).

1. **Eligibility. Entrant Eligibility.** Helmet Donation Sweepstakes in association with The Ohio Lottery, University Hospitals, and Xenith Helmets (the "Sweepstakes") is open to all legal residents of the United States. Cleveland Browns Football Company LLC ("Sponsor") is located at 76 Lou Groza Blvd., Berea, OH 44017. Employees of Sponsor, University Hospitals Health Systems, Inc., Xenith, LLC, the National Football League, its member professional football clubs and each of their respective parents, affiliates, subsidiaries and advertising and promotion agencies (collectively, "Released Parties") and their immediate family members (parent, child, spouse, sibling and their respective spouses, regardless of where they reside) and members of their households, whether or not related, are not eligible to enter or win. **School Eligibility.** Only those schools which meet the following criteria are eligible to receive a Prize in accordance with these Official Rules: (i) be an accredited secondary school or high school located within the state of Ohio and NOT having a zip code within 75 miles of Cincinnati, Ohio (go to [this link](#) to see if your school's zip code is at least 75 miles outside of Cincinnati), (ii) have a high school football program, and (iii) be [Heads-Up certified](#) (or must complete the Heads-Up certification prior to and as a condition of receiving a Prize). All applicable federal, state and local laws apply. Void where prohibited. The Sweepstakes is in no way sponsored, endorsed, administered by or associated with Facebook, Twitter or any other social media platform.

2. **Promotion Period:** Starts at 5:00:00 pm Eastern Time ("ET") on 9/16/2019 and ends at 11:59:59 pm ET on 1/31/2020 ("Promotion Period").

3. **How to Enter:** To receive one (1) entry to the Sweepstakes, during the Promotion Period either (A) visit <http://promotions.clevelandbrowns.com/contest/3682> (the "Website") and follow the instructions to complete and submit one (1) Official Entry Form. After submitting the Official Entry Form by visiting the Website, you will be prompted to "share" the Sweepstakes via your personal social media accounts and, if a new individual registers for the Sweepstakes as a result of your sharing, you will receive ten (10) additional bonus entries. Each entry must be received during the Promotion Period to be eligible. **One (1) entry per person and per e-mail address will be accepted during the Promotion Period (not including bonus entries awarded in accordance with these Official Rules). Additional entries received from the same person or e-mail address in excess of the stated limitation will be void. By submitting an Official Entry Form, entrants agree to (i) the terms of these Official Rules, (ii) the decisions of the Sponsor, which will be final and binding in all disputes and in all matters relating to the Sweepstakes, (iii) the sharing of their information with Released Parties, and (iv) the Cleveland Browns privacy policy located at <https://www.clevelandbrowns.com/about/privacy-policy>.**

4. **Winner Selection:** For **Grand Prize 1**, one (1) potential Grand Prize winner will be randomly selected from among all eligible schools nominated during the Promotion Period. For **Grand Prize 2**, one (1) potential Grand Prize winner will be randomly selected from among all eligible schools nominated during the Promotion Period and located within the following Northeast Ohio counties: Ashland, Ashtabula, Columbiana, Cuyahoga, Erie, Geauga, Huron, Lake, Lorain, Mahoning, Medina, Portage, Richland, Stark, Summit, Trumbull, Tuscarawas, and Wayne. Each Grand Prize winner will be selected by 11:59:59 pm ET on 2/15/2020.

Sponsor will contact potential winners via phone or email. An authorized representative from the potential winning school must execute and return an Affidavit of Eligibility, Liability and Publicity Release prior and as a condition to receiving any prize. Noncompliance with these Official Rules, the inability of Sponsor to contact the potential winner within a reasonable time period, or prize or prize notification being returned as non-deliverable may result in disqualification and, time permitting, and at Sponsor's sole discretion, an alternate winner being selected. Odds of winning a prize will depend on the total number of eligible entries received and schools nominated during the Promotion Period and prior to the Entry Deadline for the prize. **Any school which has been awarded new helmets from Sponsor or the Cleveland Browns Foundation in the past three (3) years shall be ineligible to win a Grand Prize.**

All costs and expenses associated with the acceptance and use of a prize not specified herein as being awarded, including, but not limited to, all federal, state and local taxes and any travel required to redeem or claim a prize, are winner's sole responsibility, and winners shall indemnify and hold the Released Parties harmless in all respects related thereto. All prize details are at the sole discretion of Sponsor and the Released Parties and are subject to change. Prizes may not be substituted for cash value.

Grand Prize. One (1) donation of new five-star certified Xenith football helmets having a value of twenty-five thousand dollars (\$25,000) will be awarded to each of two (2) eligible Schools as follows: one (1) School located within Northeast Ohio (defined below) and one (1) School located within the state of Ohio, minus the 75-mile radius around Cincinnati. "Northeast Ohio" shall be defined to include the following counties: Ashland, Ashtabula, Columbiana, Cuyahoga, Erie, Geauga, Huron, Lake, Lorain, Mahoning, Medina, Portage, Richland, Stark, Summit, Trumbull, Tuscarawas, and Wayne.
